Finance Matters

A number of matters cause delays in processing of membership payments, uniform and name badge orders, and anything else concerned with

financial operation of the Association.

When uniforms are ordered by members, the payment MUST be accompanied by an **order form**. When the order form is missing, there is nothing to associate the payment to—this makes processing of orders very difficult for the Treasurer and Property Officer.

If the payment is made online or by direct payment to the Bendigo Bank, there has to be some association between the payment and what the member is purchasing. A note in the comments section of the online or direct payment such as the members name and membership number greatly assists the treasurer in acquitting your payment against the request form.

The same principle also applies to membership dues; the convenor can make a payment directly into the VBSA bank account but a comment must accompany the payment so the association with the completed form sent by mail or email can be made.

Life for our Treasurer and Property Officer can be made so much easier if each payment can be associated to the appropriate form submitted by the member or convenor either as an attachment to an email or sent to our postal address.

Elsewhere you will note that the cost of our uniform has been increased. The increase has come about because our initial order was for a large quantity of uniforms giving some scale of economy for the garment manufacturer. Since the initial rush by many members to purchase the new uniform, supplies now being ordered are for much smaller quantities to maintain a small supply of popular sized garments.

ALL members must have the new uniform from the commencement of the 2013 season. If the members who have not purchased the new uniform can provide a large order, then we maybe able to arrange another "once off" order at reduced cost—worth thinking about?

Answers to last issue's questions

1. During an alternating possession throw-in by Red Team, Red 5 is assessed a foul for an illegal screen. Shall Red Team lose its right to the alternating possession?

No. If a foul is committed by either team during the alternating possession throw-in, the team making the throw-in does not lose its right to the next possession. Art 12.5.6

2. With 1:27 left in the 4th period, Red 4 scores a field goal. Blue 10 requests and is granted a substitution. Coach of Red Team then requests a time-out. Shall the request be granted?

Yes. The official has interrupted the play, the ball is dead and the game clock stopped. Art 18.2.8

3. Red 5 is awarded two free throws. While the ball is dead following the first free throw, Red 5 is assessed a technical foul. Substitute Red 10 now requests to enter the game to replace Red 5. Shall Red 10 be permitted to enter the game immediately?

No. The administration of the free throws by Red 5 must be completed before the substitution may be permitted. Art 19.3.9
